3. Staff Reports

A. Facilities Update – Terrie for Luke

- Tree removal: Luke & Ricardo will remove two trees from upper deck. Potentially place two, nice, permanent garbage cans in base area once trees are removed.
- Bulk liquid chlorine option: Still working out details with vendor.
- Clubhouse sconces: Luke & Ricardo replaced outside clubhouse sconces. They will move forward with sourcing and replacing the sconces inside the clubhouse.
- Purchase of magnetic whiteboard along breezeway wall in clubhouse & TV for casting & streaming for clubhouse underway

B. Club Manager's Report – Terrie

- Delinquent Dues:
 - o No new collections as of October 18, 2021. Two of three in collections have paid.
 - o 16 late notices will be sent end of day, October 21, 2021
 - o Seven new delinquent accounts over a year old have been identified. Final notices will go out on October 21, 2021.
